ABUSE RISK REDUCTION

To reduce the risk of abuse, **service providers** must know about abuse, perpetrators, signs of abuse, social inhibitors, laws about reporting, and most importantly, how to (and how not to) respond to discovery or disclosure of abuse. This training will also include discussion of incorporating abuse risk reduction into agency policy and practice manuals, detailed instructions on risk reduction strategies, employment issues, insurance, overall mission of the program, and reporting.

ABUSE DETECTION AND RESPONSE

This course will identify the various types of abuse, as well as signs and signals of abuse.
